SUBJECT: Home Energy Score Model Ordinance Update

## **Requested Action**

This item is for information only. No action is necessary.

## Background

During the 2023 Thurston Climate Mitigation Collaborative (TCMC) Annual Retreat and subsequent Executive Committee (EC) meeting, the TCMC agreed to advance two regional initiatives for focused regional coordination in 2024:

- 1. Develop and launch a Residential Energy Efficiency and Electrification Campaign; and
- 2. Develop and propose a regional Home Energy Score (HES) Disclosure Policy.

In January 2024 the Staff Team presented the EC with a memorandum and <u>proposed project plan</u> to achieve both 2024 regional initiatives. The Staff Team has utilized this proposed project plan to guide its work, and is now providing an update.

## **Progress Update**

The project team has completed Steps 1 and 2 and portions of Step 3 of the Project Plan including the following tasks and deliverables:

### Step 1: Policy Research

- 1.1 Execute interlocal agreement for 2024 TCMC regional initiatives
- 1.2 Market assessment
- 1.3 Policy research
- 1.4 Policy goals and code concepts

## Stakeholder Engagement

On March 27, 2024 the City of Olympia opened a <u>competitive solicitation</u> and subsequently contracted with Confluence Communications to conduct stakeholder engagement for both 2024 Regional Initiatives. The Staff Team worked with Confluence Communications to develop a series of in-person focus groups.

The Staff Team reached out to 40 individuals from targeted stakeholder groups (realtors, mortgage brokers, building and construction industry, home and energy inspectors, first-time homebuyers, PSE, and low-income housing and weatherization service providers. Ultimately, 18 of those individuals agreed to be part of four in-person focus groups which were held during the week of September 16-20, 2024. A fifth focus group is currently being scheduled to be held virtually with stakeholders identified in the previous four focus groups as having not been included initially (underwriters, Utilities and Transportation Commission (UTC), etc.).

## Draft Model Ordinance and Proposal for Supporting Program

## **Step 4: Refine Model Ordinance and Proposal for Supporting Program**

- 4.1 Publish draft ordinance for stakeholder and community review and feedback
- 4.2 Brief jurisdiction advisory boards, committees, commissions, etc.
- 4.3 Brief TCMC CAW and EC
- 4.4 Revise model ordinance, program proposal, and budget, as needed, to address stakeholder and jurisdiction comments

**Step 5: Jurisdictions consider Ordinance Adoption**

March/April 2025	First and Second Adoption Hearings at City Councils/County Commission
